Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Prior to activation, licensee must coordinate with Western Area Frequency Coordinator at (760) 939-6948.
- (4) Upon notification from the FCC, operation on this assignment is subject to immediate cessation, if it causes harmful interference to Navy assignments.
- (5) The designated point-of-contact if having interference occurs is Steve Dunton 310-364-9337 (Office)/310-292-8524 (Cell).

Special Conditions:

- (6) Licensee must maintain separation from the grand fathered earth stations as defined in Part 90 subpart Z, or coordinate an agreement with the grandfathered earth station licensees prior to accessing to 3650-3700 MHz.
- (7) Consult the ULS database to ensure that the operation will not cause harmful interference to any existing registered station in the 3650-3700 MHz, and notify the registered users in each area prior to operation in 3650-3700 MHz.
- (8) The applicant must coordinate its operations in the 3550-3700 MHz band with one or more authorized Spectrum Access System (SAS) administrators to obtain channel assignments and avoid causing harmful interference to authorized users of the band, including General Authorized Access (GAA) users.
- (9) Licensee should be aware that this authorization is issued on a non-interference and secondary basis. Licensee shall not cause interference to or claim protection from interference caused to it by any lawfully operating stations.
- (10) Licensee must successfully coordinate with the local Society of Broadcast Engineers frequency coordinator in the proposed area prior to performing the experiments.
- (11) Licensee must successfully coordinate with the Fixed Microwave Service licensees in the proposed area in accordance with 47 C.F.R, Part 101.103(d) prior to conducting the experimental operation
- (12) The operation is limited to indoor testing.
- (13) The licensee shall, at all times, take all necessary measures to ensure that operation of ten RF cameras does not create potential exposure of humans to radiofrequency radiation in excess of the FCC exposure limits defined in 47 CFR §§ 1.1307 and 1.1310. A warning sign must be placed to inform workers keeping distance away from areas that do not meet the limits of both occupational/controlled exposure and for general population/uncontrolled exposure.
- (14) Operation is not permitted using the frequency band 3700-4200 MHz.
