Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Licensee must coordinate with other users as necessary to minimize the interference prior to operation.
- (4) The designated point-of-contact to terminate the system if having interference occurs is Sarah Perry at 610-591-7773 or 206-902-8076.
- (5) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to authorization with the Area Frequency Coordinator (AFC), who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with AFC, as necessary to ensure compatibility with the existing uses.
- (6) Operation in the frequency band 2345-2360 MHz is subject to prior coordination with the Wireless Communications Service (WCS).

Special Conditions:

- (7) Operation is NOT permitted using the following frequency band 2213-2217 MHz and 2248.5-2285.5 MHz.
- (8) The operations authorized herein shall not cause harmful interference to, and shall not claim protection from harmful interference caused by, a station operating in accordance with the provisions of the ITU Constitution, the ITU Convention, and the ITU Radio Regulations.
- (9) All usage at Middletown DE & Lakehurst NJ is coordinated with the Regional Telemetry Coordinator (Mr. Joe White, 301-342-1542 at the Atlantic Test Range, Bld. 2118, paxrtpssched@navy.mil or joseph.white@navy.mil).
- (10) Prior coordination/scheduling are required with Dallas Area Flight Test Radio Coordinating Committee prior to using in Greenville, TX location. Point of contact is (primary) Wayne Morris 903-457-6949 and (secondary) Don Barnett 817-777-3826.
