Special Conditions:

- (1) Operation in the 1850-1910 or 1930-1990 MHz band requires prior frequency coordination with 2 GHz microwave users and consent of PCS licensees to avoid interference.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) To avoid harmful interference to Gateway receive Earth stations in the Mobile-Satellite Service (MSS) using Non-Geostationary Satellite Orbits (NGSO) in the frequency range 19.3-19.7 GHz sufficient distance shall be maintained between the experimental transmitting station and NGSO MSS Gateway Earth Stations.
- (5) To avoid harmful interference to receiving space stations in the Mobile-Satellite Service (MSS) using Non-Geostationary Satellite Orbits (NGSO) in the frequency range 29.1-29.5 GHz, sufficient angular separation shall be maintained between the experimental transmitting station and NGSO MSS space stations.
- (6) Operation is NOT permitted on the frequency bands: 1559-1610 MHz, 1626.5-1670 MHz, 2210-2220 MHz, 21200-24050 MHz, 24250-24650 MHz, 25050-25250 MHz, 27500-30000 MHz, 31200-31800 MHz, 38600-39500 MHz, 40500-42500 MHz, 47000-48200 MHz, 51400-54250 MHz, 58200-59000 MHz, 64000-65000 MHz, and 75500-76000 MHz due to potential interference Federal Government operations.
