- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) Operation is subject to prior coordination with FAA Headquarters Spectrum Assignments and Engineering.
- (4) The designated point-of-contact to terminate the systems if interference occurs is Eric Singer 757-771-7259.
- (5) Operation the frequency bands 128.825-132 MHz and 136.5-136.975 MHz are permitted using only the certain frequencies 129.875 MHz, 130.675 MHz, 131.175 MHz, 131.875 MHz, 136.525 MHz and 136.625 MHz.
- (6) Operation the frequency bands 128.825-132 MHz and 136.5-136.975 MHz are subject to prior coordination with Aviation Spectrum Resources, Inc. (ASRI).
- (7) The test will be conducted on the ground and in a hanger.
- (8) Operation is NOT PERMITTED using the frequency 122.275 MHz.
