- (3) The test shall include the assurance of the operational of the transmitting antenna and cannot be conducted with a hat or any RF absorbing devices.
- (4) Assignment will comply with Manual of Regulations and Procedures for Federal Radio Frequency Management section 4.3.18 when operational.
- (5) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by contract number FA8107-05-C-0001. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application enumerated above.
