- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) Stop Buzzer for Operation: Insitu OAC: 1-509-637-4691
- (4) Licensee must successfully coordinate with the local Society of Broadcast Engineers frequency coordinator in each proposed area prior to accessing to 18.7-21.2 GHz bands.
- (5) Licensee must successfully coordinate with the Fixed Microwave Service licensees in each proposed area in accordance with 47 C.F.R, Part 101.103(d) prior to operation in 18.7-21.2 GHz and 29-31 GHz bands.
- (6) The outdoor test set up shall be oriented such that the power transmitted toward the GSO arc is minimized.
