Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (3) The Boeing Company must coordinate with the Fixed Microwave Service licensees prior to operation in 37.5-43.5 GHz band in accordance with 47 CFR, Part 101.103(d).
- (4) The band 40-40.5 GHz is designated for satellite operations and must be notched.
- (5) In accordance with ITU Regulation para. 5.340 and US246, no transmissions are allowed in the following bands:
 - a. 50.2 - 50.4 GHz
 - b. 52.6 - 54.25 GHz

Special Conditions:

- (6) NTIA does not support the development of non- satellite equipment that utilize the 40-40.5 GHz Band.
- (7) NTIA concurs with the remaining requested bands.
- (8) The "Stop Buzzer" point of contact is Gary Stuck at 480-544-4275.
- (9) The following bands must not be utilized to protect Radio Astronomy operations in the area:
 - a. 42.5 to 43.5 GHz
 - b. 48.94 to 49.05 GHz.
- (10) Licensee must avoid pointing the transmitting antenna within 10 degrees of any point on the geostationary orbit arc while transmitting the narrow emission (NON) signals in the 47-50.2 GHz and 50.4-51.4 GHz band.
- (11) Operations must be a Non Interference Basis (NIB)/Non Protected Basis (NPB)/Not Prejudice to future decisions (NPFDD).
