- (5) Operation in the 824-849 or 869-894 MHz band requires consent of local cellular licensee(s) to avoid interference.
- (6) NO TRANSMISSIONS ARE PERMITTED ON 156.8 MHz AND 243 MHz.
- (7) Operation is subject to prior coordination with the Economic Area licensees and Multiple Address Service licensees, (Auctioned spectrum), indicated in Part 101, Subpart O.
- (8) No transmissions will occur between 406.0-406.1 MHz to protect EPIRBS.
- (9) The following frequencies need to be notched +/- 12.5 KHz to protect operations in the area:
163.15 MHz, 164.25 MHz, 164.625 MHz, 164.75 MHz.
