139-148 MHz , 162-174 MHz, and 406.1-420 MHz.
- (7) Operation on this assignment is subject to immediate cessation, if it causes harmful interference.
- (8) Operation is NOT PERMITTED using the following frequency bands:
19.99-20.01MHz, 24.99-25.01 MHz, 413.1-413.125 MHz, 758-776 MHz, 788-806 MHz and 2417-2450 MHz.
