- (4) Airborne receiver authorized herein must not be used for air traffic control communications.
- (5) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.
- (6) The authorized station must be in compliance with the Federal Aviation Administration (FAA) requirements as set forth in Section 17.4 of the Commission's Rules.
