Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (2) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (3) The station identification requirements of Section 5.115 of the Commission's Rules are waived.
- (4) Further request to operate in the band 2900-3100 MHz requires prior coordination with FAA Eastern Regional Office, JFK International Airport, NY 11430, Attn: Frequency Management Office; Telephone 718-712-8343.
- (5) Operation is subject to notification of the following within 50 miles of the test area:
 - o Location & Monitoring Service licensees (910-920 MHz)
- (6) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by the U.S. Government; contract number: AGS-1655693. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
- (7) The authorized station must be in compliance with environmental requirement set forth in Section 1.1307 of the Commission's Rules.
