- (4) This frequency assignment in one of the bands 1435-1525, 2310-2320 and 2345-2390 MHz was coordinated prior to authorization with the HQ USAF Frequency Coordinator, Alexandria, VA., who also coordinated it, as appropriate, with the Aerospace and Flight Test Radio Coordinating Council. Use of this frequency under the authority of this assignment is subject to such further coordination with the HQ USAF Frequency Coordinator, Alexandria, VA., as necessary to ensure compatibility with existing uses.
- (5) Operation the frequency band 7250-7750 MHz and 8000 - 8400 MHz on this assignment is subject to immediate cessation if it causes harmful interference to NIB to FAA assignments.
