Special Conditions:

- (1) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.

- (3) Communications with an operational satellite is not authorized.
- (4) Experimental station shall use the minimum power level necessary to establish communications links to minimize potential interference to licensed users.

- (6) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.

Special Conditions:

- (7) This authorization is issued for the express purpose of conducting experimental operations described in the related application and required by US Navy Research Labs, contract # 15-C-3102 PO_CE485157. The use of this radio station in any other manner or for any other purpose will constitute a violation of the privileges herein authorized. Except as subsequently authorized by the Commission, this radio station shall not be operated after the expiration date of the contract designated in the related application and enumerated above.
