Special Conditions:

- (1) Marketing of devices (as defined in 47CFR2.803 of this chapter) or provision of services for hire is not permitted.
- (2) All transmitting and/or receiving equipment used in the study shall be owned by the licensee.
- (3) Licensee is required to ensure that trial devices are either rendered inoperable or retrieved by them from trial participants at the conclusion of the trial. Licensee is required to notify trial participants in advance that operation of the trial device is subject to this condition.
- (4) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (5) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (6) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (7) Maintain operation separation from the grandfathered earth stations as defined in Part 90, Sub-part Z, or coordinate and agreement with the grandfathered earth station licensees prior to accessing to 3650-3700 MHz.
- (8) Ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users in the proposed areas.
- (9) The applicant must coordinate with the Fixed Microwave Service licensees in accordance with 47 CFR, Part 101.103(d).
- (10) Ensure that the transmitting base station antenna(s) tip down when possible and avoid point towards the horizon in order to protect satellite earth stations nearby.

Special Conditions:

- (11) Operations are on a non-interference basis (NIB) and shall not cause harmful interference to, and shall not claim protection from, interference caused to it by any other lawfully operating station and it shall cease transmission(s) immediately upon notice of such interference and notify the FCC in writing.
- (12) Any action taken or expense incurred as a result of operations pursuant to this license is solely at Vivint Wireless's risk.
- (13) Licensee be aware that FSS earth stations are licensed on these frequencies and if any interference occurs, the experimental licensee of this authorization will be subject to immediate shut down.

- (15) The market trial will not be renewed.
- (16) Non-approved equipment must be labeled.
- (17) Non-approved equipment must be retrieved.
