Special Conditions:

- (1) Licensee should be aware that other stations may be licensed on these frequencies and if any interference occurs, the licensee of this authorization will be subject to immediate shut down.
- (2) All customers participating in the experiment shall be informed that this operation is for experimental purposes only and can be cancelled at any time.
- (3) In lieu of frequency tolerance, the occupied bandwidth of the emission shall not extend beyond the band limits set forth above.
- (4) Prior to operation, licensee must coordinate with stations authorized to operate in these frequency bands that are located within a within a 25 mile radius of the transmitter.
- (5) The applicant must maintain separation from the grandfathered earth stations as defined in Part 90, sub-part Z, or coordinate and agreement with the grandfathered earth station licensees prior to operation in 3550-3700 MHz band.

Special Conditions:

- (6) The applicant must ensure that the operation will not cause harmful interference to any existing registered stations in the 3650-3700 MHz band, and notify the registered users of this band in the proposed area.
