## 1. SAR Test Exclusions Applied \_Bluetooth For FCC

According to the FCC KDB 447498 D01 v06 section 4.3.1, for 100 MHz to 6 GHz and test separation distances ≤ 50 mm, the 1-g and 10-g SAR test exclusion thresholds are determined by the following:

$$: \frac{\textit{Max Power of Channel(mW)}}{\textit{Test Separation Distance (mm)}} * \sqrt{Frequency(GHz)} \leq 3.0 \text{ for } 1 - g \text{ SAR}$$

#### where

- f(GHz) is the RF channel transmit frequency in GHz
- Power and distance are rounded to the nearest mW and mm before calculation
- The result is rounded to one decimal place for comparison

#### **Calculation Result:**

Tx frequency range: 2 402 MHz~ 2 480 MHz

Min. test separation distance: 5 mm

Based on the maximum output power of Bluetooth and antenna to use separation distance, Bluetooth SAR was not required  $[(2.5/5)^*\sqrt{2.480}] = 0.787401 < 3.0$ .
