I have a few comments on this Application. Please note that further comments may arise in response to answers provided to the questions below.

- 1. Please note that a number of exhibits are purported to be confidential. However, no request for confidentiality appears to have been provided. Please provide a request for confidentiality addressing the types of information to be held confidential.
- 2. Please note that the external photos show the WLAN and BT in the Host. However, the photos doe not clearly show how the PCMCIA card is a part of this device. If this is simply a PCMCIA card with its own ID, then it is not considered part of the ID on the host. If this PCMCIA card is an integral part of the host, please clearly show this in the external photos or please clearly show how this is an integral part of the host.
- Please note that the only internal photos provided are that of the BT. Please remove all shielding
 on the WLAN card and show both sides of the card in a separate internal photos exhibit. Please
 also note that you have not provided the internal photos of the PCMCIA card. Please provide
 internal photos showing the components of this PCMCIA.
- 4. Please note that the label states "this product contains....FCC ID: KBCIX260-PROG82BT". Please note that this is an improper label as the device does not contain this ID, the product ID is KBCIX260-PROG82BT. The label indicates that only one of the transmitters is the specific ID while the ID applies to the Host will all of the transmitters. Please provide a label that properly identifies the host with the ID and does not appear to suggest that the ID applies to only one transmitter inside the host.
- 5. Please note that there is does not appear to be any information on why this device is mobile and not portable. Please explain why SAR is not required for this device.
- 6. I could not find the channel separation plots in the report. Please explain or please specify the page on which they can be found.
- 7. Please note that the test setup photos for conducted and radiated do not look like they were done on the same type laptop. Please explain.

8. Please not that you have only provided the emissions designator and bandwidths for the PCS and Cell devices (i.e. 200KGXW. Please provide the emissions bandwidth and emissions designators for the WLAN and the Bluetooth device on the form.
