1. The modular transmitter must have its own RF shielding.	The module has its own RF shielding. Please see external photo.pdf
2. The modular transmitter must have buffered modulation/data inputs.	The modular has buffered data inputs, it is in chip U5 (39VF010) of LM-WP200RB. Please see diagram.pdf
3. The modular transmitter must have its own power supply regulation.	All power lines derived from the host device are regulated by U17 before energizing other circuits internal to the LM-WP200RB. Please see circuit.pdf
4. The modular transmitter must comply with the antenna requirements of Section 15.203 and 15.204(c).	The LM-WP200RB meets the FCC antenna requirements. Please see external photo.pdf
5. The modular transmitter must be tested in a stand-alone configuration, i.e., the module must not be inside another device during testing.	The LM-WP200RB was tested in a stand-alone configuration via a PCMCIA extender. Please see conducted set-up photo.pdf and spurious set-up photo.pdf
