


Fig.1 Photograph of the SAR Measurement System




Fig.2.1 Flat (Body)




Fig.2.2 Flat (Body)

## Body worn - distance between flat phantom and EUT is 0 mm






Fig.3 EUT Lap held mode to flat phantom







Fig.4 EUT Edge 2 to flat phantom






Fig.5 EUT Edge 1 to flat phantom




Fig.6 EUT Edge 3 to flat phantom
