










### 8.5 Radiated spurious emissions

### ■ Test Requirements and limit, §15.247(d), §15.205, §15.209

In any 100 kHz bandwidth outside the operating frequency band, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 KHz bandwidth within the band. In case the emission fall within the restricted band specified on 15.205(a) and (b), then the 15.209(a) limit in the table below has to be followed.


• FCC Part 15.205(b): The field strength of emissions appearing within these frequency bands shall not exceed the limits shown in §15.209. At frequencies equal to or less than 1000 MHz, compliance with the limits in §15.209 shall be demonstrated using measurement instrumentation employing a CISPR quasi-peak detector.

Above 1000 MHz, compliance with the emission limits in §15.209 shall be demonstrated based on the average value of the measured emissions. The provisions in §15.35 apply to these measurements.

### **■** Test Configuration



#### **■** Test Procedure

- 1. The EUT is placed on a non-conductive table, emission measurements at below 1 GHz, the table height is 80 cm and above 1 GHz, the table height is 1.5 m.
- 2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT is set 1 or 3 m away from the receiving antenna, which is varied from 1 m to 4 m to find out the highest emissions.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
- 6. Repeat above procedures until the measurements for all frequencies are complete.

#### **■** Measurement Instrument Setting for Radiated Emission Measurements.

The radiated emission was tested according to the section 6.3, 6.4, 6.5 and 6.6 of the ANSI C63.10-2013 with following settings.

#### **Peak Measurement**

RBW = As specified in below table, VBW ≥ 3 x RBW, Sweep = Auto, Detector = Peak, Trace mode = Max Hold until the trace stabilizes.

#### **Average Measurement:**

- 1. RBW = 1 MHz (unless otherwise specified).
- 2. VBW ≥ 3 x RBW.
- 3. Detector = RMS (Number of points ≥ 2 x Span / RBW)
- 4. Averaging type = power. (i.e., RMS)
- 5. Sweep time = auto.
- 6. Perform a trace average of at least 100 traces.
- 7. A correction factor shall be added to the measurement results prior to comparing to the emission limit in order to compute the emission level that would have been measured had the test been performed at 100 percent duty cycle. The correction factor is computed as follows:
- 1) If power averaging (RMS) mode was used in step 4, then the applicable correction factor is 10 log(1/x), where x is the duty cycle.
- 2) If linear voltage averaging mode was used in step 4, then the applicable correction factor is 20 log(1/x), where x is the duty cycle.
- 3) If a specific emission is demonstrated to be continuous (≥ 98 percent duty cycle) rather than turning on and off with the transmit cycle, then no duty cycle correction is required for that emission.

#### 8.6 Power-line conducted emissions

### ■ Test Requirements and limit, §15.207

For an intentional radiator which is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table, as measured using a 50 uH/50 ohm line impedance stabilization network(LISN).

Compliance with the provision of this paragraph shall on the measurement of the radio frequency voltage between each power line and ground at the power terminal. The lower applies at the boundary between the frequency ranges.

Compliance with this provision shall be based on the measurement of the radio frequency voltage between each power line (LINE and NEUTRAL) and ground at the power terminals.

#### **■** Test Procedure

- 1. The EUT is placed on a wooden table 80 cm above the reference ground plane.
- 2. The EUT is connected via LISN to the test power supply.
- 3. The measurement results are obtained as described below:
- 4. Detectors Quasi Peak and Average Detector.



When an occupied bandwidth value is not specified in the applicable RSS, the transmitted signal bandwidth to be reported is to be its 99 % emission bandwidth, as calculated or measured.

#### **■ TEST PROCEDURE**

- The transmitter shall be operated at its maximum carrier power measured under normal test conditions.
- The span of the analyzer shall be set to capture all products of the modulation process, including the emission skirts.
- The resolution bandwidth (RBW) shall be in the range of 1% to 5% of the occupied bandwidth (OBW) and video bandwidth (VBW) shall be approximately 3x RBW.





**Occupied Bandwidth** Test Mode: 802.11b & 1 Mbps & 2412 MHz




#### **Occupied Bandwidth** Test Mode: 802.11b & 1 Mbps














### Occupied Bandwidth Test Mode: 802.11g & 24 Mbps & 2412 MHz




## Occupied Bandwidth Test Mode: 802.11g & 24 Mbps & 2437 MHz



















#### Test Procedure

#### Duty Cycle was measured using section 6.0 b) of KDB558074 D01V04:

The zero-span mode on a spectrum analyzer or EMI receiver if the response time and spacing between bins on the sweep are sufficient to permit accurate measurements of the on and off times of the transmitted signal. Set the center frequency of the instrument to the center frequency of the transmission. Set RBW ≥ OBW if possible; otherwise, set RBW to the largest available value. Set VBW ≥ RBW. Set detector = peak or average.


The zero-span measurement method shall not be used unless both RBW and VBW are > 50/T and the number of sweep points across duration T exceeds 100. (For example, if VBW and/or RBW are limited to 3 MHz, then the zero-span method of measuring duty cycle shall not be used if T  $\leq$  16.7 microseconds.)








Duty Cycle TM 2 & Middle



Duty Cycle TM 3 & Middle




