Eschelon Telecom, Inc. takes this opportunity to update Commission records. First, as Eschelon has previously advised the Commission, Eschelon Telecom, Inc. and the wholly-owned subsidiaries listed on Annex A are operating pursuant to the Section 214 authorization currently issued to, validly existing, and held by Eschelon Telecom, Inc. (ITC-214-19990729-00490).¹ The states of incorporation and the names of these wholly-owned subsidiaries are listed on Annex A.

Second, as the subsidiaries listed on Annex A are operating pursuant to their parent's Section 214 authorization, Eschelon Telecom, Inc. respectfully surrenders the prior international Section 214 authorizations issued to these subsidiaries. The ITC file numbers of these prior Section 214 authorizations are listed on Annex A.
