Ownership Information and Foreign Carrier Affiliation Statement

Applicant: TeleArc LLC

TeleArc LLC (“Applicant”) submits this statement in support of its application for international Section 214 authorization pursuant to Section 63.18 of the Commission’s rules, 47 C.F.R. § 63.18.

1. Place of Organization

The Applicant is a limited liability company organized under the laws of the State of Colorado, United States of America (Colorado Secretary of State Entity ID 20261696613). The Applicant maintains its principal place of business at 6429 S Vinewood St, Apt 201, Littleton, Colorado 80120, United States.

2. Ownership Structure

The Applicant is a single-member limited liability company. Mr. Tareq Almaqrami holds a 100 percent direct equity and voting interest in the Applicant. No other person or entity holds any direct or indirect equity or voting interest, or any controlling interest, in the Applicant.

3. Citizenship and Immigration Status of Sole Member

Mr. Tareq Almaqrami, the sole member of the Applicant, is a citizen of the Republic of Yemen. Mr. Almaqrami has been a lawful permanent resident of the United States and is the holder of a United States Permanent Resident Card. Mr. Almaqrami resides in the United States at the Applicant’s principal place of business identified above and conducts the Applicant’s operations from within the United States.

4. Foreign Ownership Disclosure (47 C.F.R. § 63.18(h))

In response to the Commission’s inquiry regarding non-U.S.-citizen ownership: the Applicant’s sole member, Mr. Tareq Almaqrami, is a citizen of the Republic of Yemen and a lawful permanent resident of the United States. Mr. Almaqrami holds a 100 percent direct equity and voting interest in the Applicant. No other foreign individual, no foreign corporation, and no foreign government holds any direct or indirect equity or voting interest, or any controlling interest, in the Applicant. No U.S. citizen or U.S. entity other than the Applicant itself holds any interest in the Applicant.

5. Foreign Carrier Affiliation (47 C.F.R. § 63.18(i)–(m))

The Applicant is not a foreign carrier. The Applicant is not affiliated with any foreign carrier within the meaning of Sections 63.09(d) and 63.09(e) of the Commission’s rules. Neither Mr. Almaqrami nor any other person holds an attributable interest in any foreign carrier. The Applicant has no affiliation with any foreign carrier in any destination country for which authority is requested. Accordingly, no additional information or certifications are required to be provided under Sections 63.18(i) through (m) of the Commission’s rules.

6. No Interlocking Directorates

The Applicant does not, and will not, have any interlocking directorates with any foreign carrier within the meaning of Section 63.18(h) of the Commission's rules.

7. Special Concessions (47 C.F.R. § 63.14)

The Applicant has not agreed to accept, and will not agree to accept, any special concessions directly or indirectly from any foreign carrier with respect to any U.S.-international route.

8. U.S.-Based Point of Contact and Agent for Service of Process

The Applicant has designated a point of contact located in the United States who is a lawful permanent resident of the United States for the execution of lawful requests, as required by 47 C.F.R. § 63.18(q)(1)(iii). The Applicant has further designated an agent for legal service of process located in the District of Columbia, in accordance with 47 U.S.C. § 413 and 47 C.F.R. § 1.47(h).
