

Response to FCC Form 312 Question 39

XM Radio LLC is a wholly owned subsidiary of Sirius XM Radio LLC which is in turn a wholly owned subsidiary of Sirius XM Inc., which is in turn a wholly owned subsidiary of Sirius XM Holdings Inc. Sirius XM Holdings Inc. has no operations independent of Sirius XM Radio LLC and its subsidiaries. As of April 2, 2026, Berkshire Hathaway Inc. ("Berkshire"), a Delaware corporation, beneficially owned approximately 37.1% of the common stock of Sirius XM Holdings Inc. Warren E. Buffett, a United States citizen, owned shares of Berkshire that represent approximately 29.7% of the voting interest and 13.2% of the economic interest as of July 14, 2026. The address of Berkshire and Mr. Buffet is 3555 Farnam Street, Omaha, NE 68131. No other entities or individuals own a 10% or greater direct or indirect interest in Sirius XM Holdings Inc.
