Puerto Rico Electric Power Authority main offices are located at Neos Building, 8th Floor, Ponce de León Avenue, Stop 17 ½, Santurce, Puerto Rico. Puerto Rico Electric Power Authority indirectly owns more than ten percent (10%) of the equity of Applicant, since it owns one hundred percent (100%) equity of PREPA Holdings, LLC and PREPA Holdings, LLC owns hundred percent (100%) equity of Applicant.

On February 28, 2008, the Puerto Rico Telephone Authority ("PRTA") a government entity of the Commonwealth of Puerto Rico, created by the Puerto Rico Law No. 25 of May 6, 1974, as amended ("Law No. 25"), was the sole owner and stockholder of Ultracom, entered into a stock purchase agreement with PREPA Networks, Corp, pursuant to which PREPA Networks Corp. acquired all outstanding shares of common stock of Ultracom owned by PRTA. In September 24, 2008, the FCC granted its consent of authority to transfer the control of all Ultracom's FCC licenses to PREPA Networks, Corp. (see Report No. SCL-00076); four years later PREPA Networks, Corp. and PREPA International Wholesale Transport, Inc. also known as Ultracom and Telecomunicaciones Ultramarinas de Puerto Rico, Inc. merged, effective March 1, 2012, with PREPA Networks, LLC, being this last one the survivor entity. Due to clerical error, the submarine cable landing interest of the Taino Carib was not assigned from PREPA Networks, Corp. to PREPA Networks, LLC. Hence, the need to file the present application.

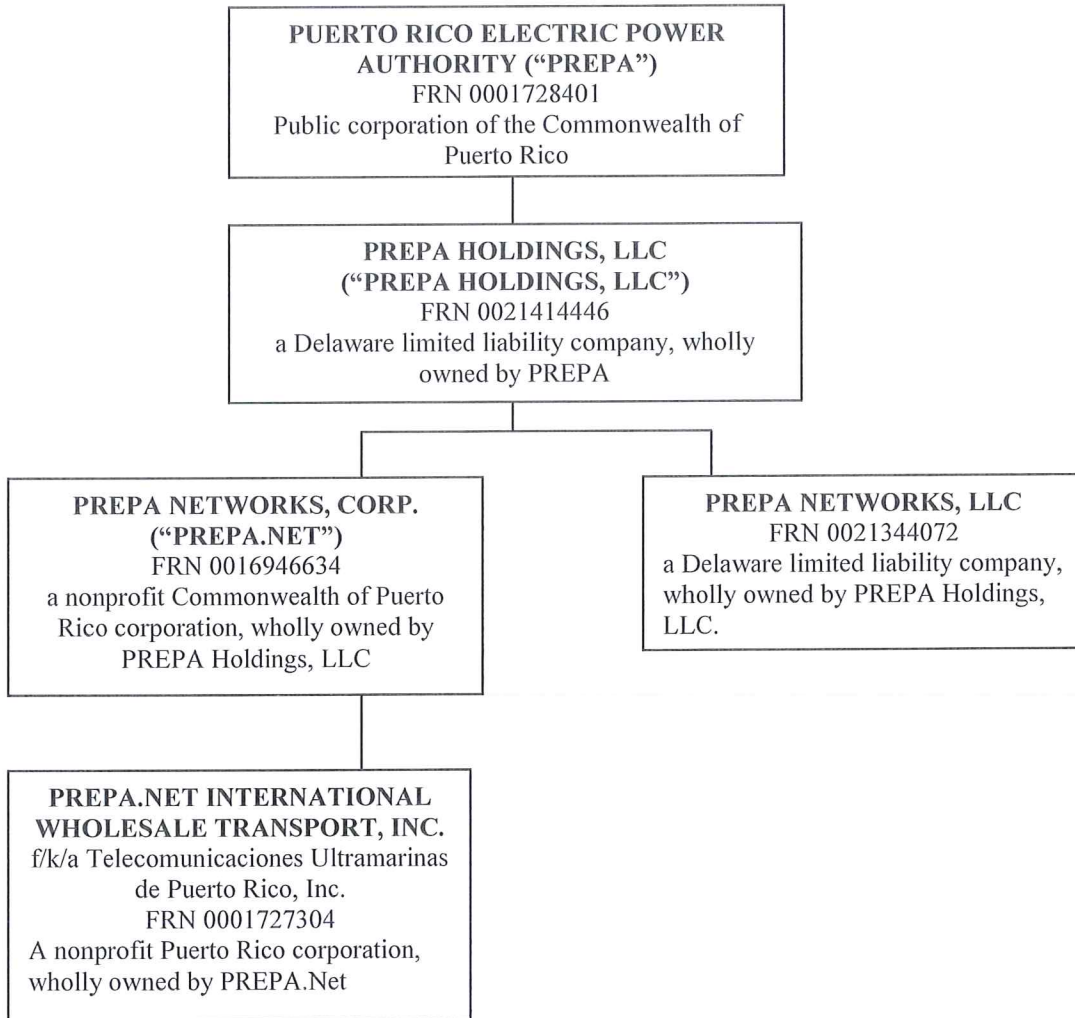

- **ORGANIZATION DIAGRAM**

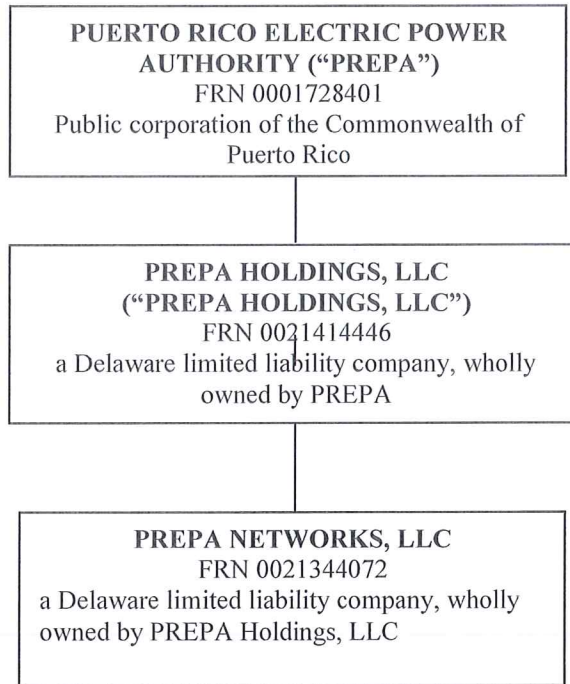
ULTRACOM OWNERSHIP PRIOR TO THE TRANSACTION (YEAR 2012)

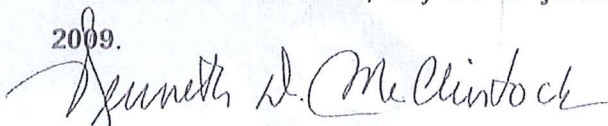
