SAT-LOA-20190704-00057, SES-LIC-20210409-00634, SES-LIC-20210409-00635, SES-LIC-20210415-00685, and SES-LIC-20210730-01290 on May 30, 2023, informing the Commission of the coordination agreement that Iridium Communications Inc. (“Iridium”) and Kuiper Systems LLC, a wholly owned subsidiary of Amazon.com Services LLC (collectively, “Amazon”), reached relating to operation in the 19.4-19.6 GHz and 29.1-29.3 GHz bands (the “Iridium Coordination Agreement”).

Dear Ms. Dortch:

Iridium Communications Inc. (“Iridium”) and Kuiper Systems LLC, a wholly owned subsidiary of Amazon.com Services LLC (collectively, “Amazon”), hereby notify the Commission they have reached a coordination agreement for the use of certain Ka-band frequencies. The parties’ agreement fulfills, with respect to Iridium, a condition of Amazon’s authorization to deploy and operate a non-geostationary satellite orbit (NGSO) system.¹

Amazon’s NGSO authorization requires it to coordinate operations in the 19.3-19.7 GHz and 29.1-29.5 GHz bands “with any previously authorized NGSO MSS systems not included in the March 2020 Processing Round over the bands designated for use by NGSO MSS feeder links.”² Iridium is such an NGSO MSS system, and it uses a portion of these bands, *i.e.*, it uses the 19.4-19.6 GHz and 29.1-29.3 GHz bands, for NGSO MSS feeder links.

With today’s submission, Amazon and Iridium are pleased to announce they have reached a coordination agreement for operations in the 19.4-19.6 GHz and 29.1-29.3 GHz bands associated with the ITU filings identified below.³ Now that Amazon and Iridium have reached a coordination agreement, Amazon withdraws its request that the Commission hold in abeyance the portion of the above-captioned earth station applications seeking authority to operate in the feeder link bands (19.3-19.7 GHz and 29.1- 29.5 GHz) pending completion of coordination with Iridium.⁴

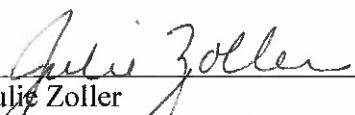

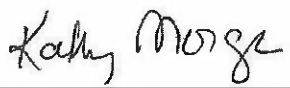
