Call Sign KA450; Napa, California

Dear Ms. Dortch:

Intelsat License LLC ("Intelsat") herein requests an additional 30 days of Special Temporary Authority ("STA")¹ previously granted to Intelsat² to use its Napa, California Ku-band earth station, KA450, to provide telemetry, tracking, and command ("TT&C") services on-station for the Intelsat 40e (S3066) satellite.³ Intelsat 40e was launched on April 7, 2023, and is currently undergoing in-orbit testing on-station at 91.0° W.L. Intelsat will seek permanent authority for the herein requested operations.

The Intelsat 40e operations are being performed at the following frequencies:
14000.0-14030.0 MHz (Earth-to-space); and
12170.0-12200.0 MHz (space-to-Earth).

In the extremely unlikely event that harmful interference should occur due to transmissions to or from its earth station, Intelsat will take all reasonable steps to eliminate the interference.

Grant of this STA extension request will allow Intelsat to provide services at the 91.0° W.L. location and thereby promotes the public interest.
