Request for 30-day Extension of Special Temporary Authority (“STA”)

Moynk Properties, LLC (“Moynk”) respectfully seeks a 30-day extension of STA previously granted to add ICEYE’s space station systems licensed under Call Signs S3165¹ and S3224² as additional points of communication to its fixed earth station located in Kapolei, Hawaii (the “Kapolei Earth Station”; Call Sign E202006).³

Grant of this STA serves the public interest because it will enable Moynk to continue to support ICEYE in accordance with its mission objectives.

Consistent with Section 1.62 of the Federal Communications Commission’s rules,⁴ Moynk will continue communicating with the ICEYE space station systems licensed under Call Signs S3165 and S3224 pursuant to the terms and conditions of its expiring STA pending grant of the instant extension request.⁵
