STA operations must not exceed the operational power levels and parameters requested and coordinated, and must comport with the technical specifications described in the underlying application, except as conditioned in this grant of STA.</div> <div>2. All Earth-to-space operations are limited to a maximum EIRP of 44.8 dBW and a maximum EIRP density of 27.8 dBW/4 kHz.</div> <div>3. STA operations must use the minimum power level necessary to establish communications links in order to minimize potential interference to licensed users.</div> <div>4. All operations under this grant of STA must be on an unprotected and non-interference basis (NIB), i.e., Viasat must not cause harmful interference to and must not claim protection from interference caused to it by any other lawfully operating station.</div> <div>5. In the event of any harmful interference caused by operations under this grant of STA, Viasat must immediately cease operations upon notification of such interference. Viasat must immediately inform the Commission, in writing, of such an event.</div> <div>6. Earth station transmissions in the 2025–2110 MHz band are subject to prior coordination with the local Society of Broadcast Engineers, Inc. (SBE) frequency coordinator. All operations shall be limited to use of right-hand circular polarization (RHCP).</div> <div>8. polar satellites, with the uplink (Earth-to-space) typically requiring less than 1 minute per visibility opportunity and the downlink (space-to-Earth) typically requiring less than 3 minutes per visibility opportunity.

10. STA operations must be in compliance with earth station applicable operations allowed by the space station authorization(s) or grant(s), including all relevant conditions, waivers, and findings therein.

11. STA operations since the expiration of the previous STA and the commencement of this STA were authorized as continuing operations under 47 CFR § 1.62.

This grant is issued pursuant to section 0.261 of the Commission's rules on delegated authority, 47 CFR § 0.261, and is effective upon release. This STA is authorized pursuant to the Commission's rule 47 CFR § 25.120.
