**PUBLIC INTEREST STATEMENT AND
DESCRIPTION OF INVOLUNTARY TRANSFER OF CONTROL**

The Estate of Janice M. Ingstad (Tanya Ingstad Knudson, PR) ("Estate" or "Transferee") hereby submit the foregoing FCC Form 312 for the involuntary transfer of control Midwest Information Systems, Inc. ("Midwest"), licensee of fixed satellite earth stations E860707 and E140126, from the late Janice M. Ingstad to her Estate. Ms. Ingstad passed away on December 9, 2016 and her daughter, Tanya Ingstad Knudson, was appointed as Personal Representative by the District Court of Grand Forks County, North Dakota, on January 6, 2017. Copies of Letters Testamentary and the Statement Appointing Personal Representative are attached hereto.

The late Ms. Ingstad owned or held controlling interests in a number of broadcast licensees, and her primary business was the operation of broadcast stations. At the time that applications for involuntary transfers of control of Ms. Ingstad's broadcasting companies were filed, the involuntary transfer of control of Midwest was inadvertently overlooked. The Estate is filing this application as soon as possible upon learning of that omission.

A grant of the subject application will permit for the prompt and efficient settlement of Ms. Ingstad's Estate, as well as allowing the Estate to continue efficient operations of the subject earth stations pending settlement of the Estate.

For all the foregoing reasons, the Estate respectfully submits that the subject application will serve the public interest and should be expeditiously granted.

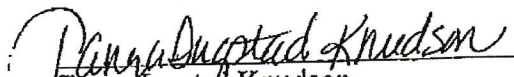

STATEMENT OF APPOINTMENT OF A PERSONAL REPRESENTATIVE

The Application of Tanya Ingstad Knudson for informal appointment of a Personal Representative having been filed with the Court, and it appearing that:

1. The decedent died on December 9, 2016, and at least one hundred twenty hours (120) have elapsed since the decedent's death; and
 - a. The Application is complete;
 - b. The Application contains the Applicant's oath or affirmation that the statements contained therein are true to the best of her knowledge and belief; and that all of the statements required by law to be made in the Application have been made;
 - d. On the basis of the statements in the Application, venue is proper;
 - e. Any notice required by the laws of this state has been given and the Application is not within Section NDCC 30.1-14-04;
 - f. The Will and Codicils to which this appointment relates appear to be the duly executed and apparently unrevoked, Will and Codicils of the decedent and is in the court's possession;
 - g. That from the statements in the Application it appears that the person whose appointments is sought is entitled to appointment by priority;
 - h. The time limit for the original probate of this Will has not expired.

i. The date of the original Will is May 21, 1997. The date of the First Codicil is February 6, 2006. The date of the Second Codicil is October 2, 2009.

2. A Personal Representative has not been appointed in another county in this state and neither the Will nor Codicil subject of this Application nor any other Will or Codicil of the decedent has been the subject of a previous probate order.

NOW, THEREFORE, IT IS ORDERED as follows:

1. The Application for informal probate is hereby granted and the Will dated May 21, 1997, the First Codicil dated February 6, 2006 and the Second Codicil dated October 2, 2009, are hereby admitted to informal probate.

2. The Application for informal appointment of a Personal Representative is hereby granted and Tanya Ingstad Knudson is hereby appointed as Personal Representative of the Estate of Janice M. Ingstad, deceased, without bond.

3. Letters Testamentary shall be issued to Tanya Ingstad Knudson upon her qualification and acceptance.
